1. Table B.1.2.1.1 Pricing Identification Structure is modified to add Software Defined Wide Area Network under Managed Service.

3. Section B.1.3.3 is renumbered to Section B.1.4. Termination of Support applies to all services (not just catalog services). Section B.1.3 is catalog-specific so Termination of Support should not have been a subsection of B.1.3.
4. Section B.2.2.1.5 is modified to correct the spelling of "contractor."
5. Section B.2.2.2.1 is modified to correct the reference in the second paragraph from Table B.2.2.2.1.4 to Section B.2.2.2.2. Section B.2.2.2.2 contains the price and instruction tables for the unlimited plans.
6. Table B.2.2.2.1.4 is modified to delete the Transport Category column to reduce confusion.
7. Table B.2.2.2.3.2 is modified to add the missing case number column and associated note.

Section J.2.10.1.1.2.2, item 3, first bullet, is modified to replace the current text with: “The component CLINs of regional bundles, as defined in Section B.1.2.12.2, are not individually considered inventory items; the contractor shall neither assign UBIs to these component CLINs nor report these component CLINs in any deliverable defined in Section J.2. The regional bundle TUC itself is considered an inventory item; the contractor shall assign a UBI to the base TUC and report it in all standard deliverables, as applicable.”
