1. The purpose of this modification is to incorporate MetTel's Submission Number ME00228.01a, dated February 21, 2019. The submission is proposing to update the optional service by CBSA table assignments to include the availability of optional Managed Trusted Internet Protocol Service (MTIPS) in 276 previously awarded Core-Based Statistical Areas (CBSAs) and an update to the Services offered by Point of Presence (PoP) Relationship Table to the contract.
