1. The purpose of this modification is to adjust the Minimum Revenue Guarantee (MRG) and deobligate excess funds to date (thru the end of contract year 5 - 07/30/2021). In accordance with H.4 Minimum Revenue Guarantee and Maximum Contract Limitation, the MRG amount is hereby reduced from \$74,944,266.00 by \$4,063,245 to \$70,881,021. The dollar amount has been rounded up, for ease of administration.
