1. The purpose of this modification is to incorporate MetTel's Submission Number ME01073.01a, dated June 8, 2022 in to the MetTel Enterprise Infrastructure Solutions (EIS) contract. This submission adds Circuit Switched Voice Service (CSVS) calling plan prices in previously awarded Country Jurisdictions. Additionally, the submission proposes to add option period one prices for domestic Access Arrangement (AA), Circuit Switched Voice Service (CSVS) features, Internet Protocol Service (IPS), and Virtual Private Network Service (VPNS) CLINs awarded for the EIS contract base period on MetTel's EIS contract. This submission also proposes to stop Non-Domestic AA prices and mapping relationship table updates.
2. The estimated dollar value of the contract remains unchanged.
3. Except as provided herein, all prices, terms and conditions of the document referenced in Item 10A remain unchanged and in full force and effect.
